

The Atonement Academy

Application for Financial Aid

The Scholarship Fund provides financial aid to needy students of The Atonement Academy, who are from families that are registered and active parishioners of Our Lady of the Atonement Catholic Church. The fund is comprised of voluntary donations from parishioners and other interested parties, and is administered by the Pastor. Because fund resources are limited, tuition assistance is based on a fully documented demonstration of financial need and active parish membership.

Generally, the following total household income thresholds apply in order to be considered for financial aid. Allocation amounts will vary depending on funds availability and number of eligible applicants. All past due tuition/fees must be paid in full before the Committee will consider this application. Family size is defined as parent(s) plus children and other relatives/dependents living as one economic unit and sharing living expenses, including rent, clothing, food, medical bills, utilities, transportation, etc.
